MEMORANDUM OF AGREEMENT

between

INTERNATIONAL ALLIANCE OF THEATRICAL STAGE EMPLOYEES AND MOVING PICTURE TECHNICIANS, ARTISTS AND ALLIED CRAFTS

OF THE UNITED STATES AND CANADA, AFL-CIO, CLC and

THE ALLIANCE OF MOTION PICTURE AND TELEIVISION PRODUCERS

This Agreement is entered into by and between the International Alliance of Theatrical Stage Employees and Moving Picture Technicians, Artists and Allied Crafts of the United States and Canada, AFL-CIO, CLC (the "IATSE"), on the one hand, and the Alliance of Motion Picture and Television Producers (the "AMPTP") on behalf of those Producers which have effectively consented to be part of the single multi-employer bargaining unit as listed on Exhibit "A" attached to the General Memorandum of Agreement of August 1, 2024 for the Area Standards Agreement between the AMPTP and the IATSE, on the other hand (with the IATSE and the AMPTP collectively referred to as the "Parties").

During their 2025 negotiations, Theatrical Wardrobe Union, Local 764, IATSE (hereinafter, "Local 764") and the AMPTP agreed, subject to agreement by the IATSE, effective [insert date that is March 2, 2025 or the first Sunday following the business day on which the AMPTP receives notice of ratification, whichever is later], that in lieu of making pension and annuity contributions to the IATSE National Pension Plan and to the IATSE Annuity Fund on behalf of employees who: (a) previously performed covered work under the Feature and Television Production Agreement or the Supplemental Digital Production Agreement between Local 764 and the AMPTP, (b) heretofore had pension and annuity benefit contributions paid into the IATSE Local 764 Pension Fund and the IATSE Local 764 Annuity Fund and (c) were engaged under the Area Standards Agreement between the IATSE and the AMPTP, the same contribution amounts, in the aggregate, shall be paid to the Local 764 Pension Fund and the Local 764 Annuity Fund in accordance with the agreement of Local 764 and the AMPTP.

During their 2025 negotiations, Local 764 and the AMPTP agreed to the following allocation of contributions:

Effective March 2, 2025, the allocations shall be as provided in the attached chart.

Local 764 and the AMPTP shall determine by mutual agreement on or before March 30, 2025 to the allocation as between the Local 764 Pension Fund and the Local 764 Annuity Fund effective August 3, 2025. Thereafter, Local 764 and the AMPTP shall attempt to agree upon an allocation for each of the periods beginning August 2, 2026 and August 1, 2027 not less than six months in advance of each of those effective dates. Should the parties fail to reach agreement on an allocation, any increase in the contribution rate shall be added to the contribution rate for the Local 764 Pension Plan.

The Parties hereby agree to use and execute the template Memorandum of Agreement between the Production Company and the IATSE attached hereto to effectuate the transfer of contributions in the circumstances described herein.

TEMPLATE MEMORANDUM OF AGREEMENT

This Agreement is entered into by and between the International Alliance of Theatrical Stage Employees and Moving Picture Technicians, Artists and Allied Crafts of the United States and Canada, AFL-CIO, CLC ("IATSE") and Signatory Employer ("Production Company") with respect to pension and annuity benefit contributions payable on behalf of [insert name of Employee] (xxx-xx-0000) employed by the Production Company on the production [insert name of Production] (the "Production") who has previously performed covered work under the Feature and Television Production Contract between Theatrical Wardrobe Union, Local 764 and Major Motion Picture Producers and has heretofore had pension and annuity benefit contributions paid into the IATSE Local 764 Pension Fund and the IATSE Local 764 Annuity Fund.

In lieu of making pension and annuity contributions to the IATSE National Pension Plan and to the IATSE Annuity Fund, the Production Company agrees to make pension and annuity benefit contributions to the IATSE Local 764 Pension Fund and to the IATSE Local 764 Annuity Fund instead. The contribution amount to be paid to the Local 764 Pension Fund and the Local 764 Annuity Fund shall be, in the aggregate, the same as the amounts that would otherwise have been payable to the IATSE National Pension Plan and the IATSE Annuity Fund. However, such amount shall be allocated between the Local 764 Pension Fund and the Local 764 Annuity Fund in accordance with the agreement of Local 764 and the AMPTP.

During their 2025 negotiations, Local 764 and the AMPTP shall agree upon an allocation as between the Local 764 Pension Fund and the Local 764 Annuity Fund effective March 2, 2025 and an allocation effective August 3, 2025. Thereafter, Local 764 and the AMPTP shall attempt to agree upon an allocation for each of the periods beginning August 2, 2026 and August 1, 2027 not less than six months in advance of each of those effective dates. Should the parties fail to reach agreement on an allocation, any increase in the contribution rate shall be added to the contribution rate for the local 764 Pension Plan.

The parties agree to execute any Trust Acceptance(s) or other additional documents that may be required by the IATSE National Benefit Funds, the IATSE Local 764 Pension Fund and the IATSE Local 764 Annuity Fund in order to effectuate the foregoing agreement.
